FISCAL YEAR 2019/2020 BUDGET**

MARCH 26, 2019

The Shenandoah Town Council held a public hearing on Tuesday, March 26, 2019, beginning at 7:00 p.m., with Mayor Clinton O. Lucas, Jr., presiding.

The meeting began with the Pledge of Allegiance.

ATTENDANCE: Council Members present were: Mayor Clinton O. Lucas, Jr.; Vice Mayor William Kite; Councilmen Russell Comer, Jr.; Charles Jenkins; I. Michael Lowe; and Richard Pierce.

Council Members absent were: Councilman Lynn Fox.

Other Town Officials present were: Juanita F. Roudabush, Town Manager/MMC; Sarah Dean, Town Clerk; and Paul Davis, Chief of Police.

Citizens present were: Mike Uram, Whitley McCoy, Alyssa Gray, and Annie Pierce.

Media Representatives: There were no media representatives present at this meeting.

CALL TO ORDER: Mayor Lucas opened the public hearing at 7:00 p.m. He stated the purpose of this Public Hearing is to discuss the proposed Fiscal Year 2019/2020 Budget for the Town of Shenandoah. He noted each member received a copy of the proposed budget for review. He also stated the proposed budget was advertised in a local newspaper, and a copy has been on display in the Town Office for the public to review.
