Mayor Lucas stated the Town would be saving a lot by not having Playground Specialists install the equipment.

Town Manger Roudabush stated this entire piece of equipment will be paid out of the \$20,000.00 donation by Linda Breeden in Memory of Dave Hinkle.

Councilman Comer stated the vote on Correspondence #10 will add a line item just for the rent from the AT&T tower and it will be separated from the Shenandoah Post Office rent.

Councilman Pierce asked if the Sewer Plant has the capacity to handle the new construction in Town.

Town Manger Roudabush stated the Sewer Plant has extra capacity now, but in the future the Council would need to make plans to upgrade.

TOWN MANAGER'S REPORT

Town Manager Roudabush stated the Sewer Plant had been testing out a used (but like new) bucket on the skid loader. The bucket had made cleaning out the drying beds easier and made the work less time consuming. Town Manager Roudabush stated the bucket was available for purchase for \$1,000.00.

Kite, to approve the purchase of the used bucket for the skid loader in the amount of \$1,000.00 to be paid from Utility Fund Capital Outlay Reserved for Contingency budgeted line item.
